1. Prices set out in our price list are subject to change without notice.
2. If terms of trading are not adhered to or there are amounts owing on your account, dispatch of goods will be withheld until the account is brought within our terms as per clause 3 in our terms and conditions.
3. Goods made to special order are not returnable and drawings are required before manufacture of products will commence.
4. Damaged or non-delivered goods must be notified within 1 day of the date of dispatch. We will require a signature and inspection of goods before leaving, if the work site or place of delivery is unattended at time of delivery we will unload goods at kerbside and the time, date, location and photo evidence will be taken prior to departure. If this is also deemed not liable we may deliver the goods back to A2Z and withhold them at buyers' expense. It will then be the buyers' responsibility for any damage or pilfering that occurs after A2Z Flashings has made delivery of items.
5. We will not nominate a given time for the delivery of goods however we will endeavour to deliver on your nominated day. If you require delivery of goods at a particular time please notify us for special arrangements prior to placing your order with us.
6. A2Z Flashings will need all information on order forms to be correct for efficient next day delivery, any errors will need to be clarified with customers and may cause a delay in your next day delivery.
7. Unloading of goods are the buyers responsibility, the delivery driver will only unload goods that are applicable with one person, any other flashing will need to be unloaded by the buyer or with mechanical assistance arranged by the buyer.
